**ADMINISTRATIVE ORDER**

The Chief Judge of the Shawnee County District Court hereby enters this Administrative Order appointing Marc A. White as Court Trustee for the Third Judicial District pursuant to the provisions of K.S.A. 20-377.

**WHEREAS**, the Court finds that Marc A. White is a qualified attorney who is licensed to practice law in the State of Kansas; and,

**WHEREAS**, the Court finds that Marc A. White is currently serving as the District Court Trustee in the Third Judicial District of Kansas; and,

**WHEREAS**, the Court finds that Marc A. White should continue to serve as the Court Trustee in the Third Judicial District of Kansas; and,

**WHEREAS**, the Court finds that it is appropriate to minimize the costs of collecting child support and to maximize the amount of support collected for the benefit of minor children; and,

**WHEREAS**, the Court finds that in order to minimize expenses and to maximize collections for the benefit of minor children, the expertise, equipment, and personnel of Marc A. White should be utilized to the maximum possible extent.

**THEREFORE**, the Court enters the following Order:

1. Marc A. White is hereby appointed to serve as District Court Trustee for the Third Judicial District, commencing on February 1, 2018, pursuant to the terms of K.S.A. 23-494 *et seq.* The Trustee may delegate legal work to Deputy Court Trustees, subject to the approval of the District Court.

2. The District Court Trustee shall monitor, enforce and collect all non IV-D support orders, in the Third Judicial District pursuant to K.S.A. 20-378 and K.S.A. 20-379.

3. The District Court Trustee shall obtain and operate an office outside of the Shawnee county Courthouse and shall bear the expenses related to maintaining the office.

4. The District Court Trustee shall provide all support staff necessary for the performance of this Order, including the employment of Deputy District Court Trustees, at his expense.

5. The District Court Trustee shall serve at the pleasure of the Chief Judge of the Third Judicial District. Notwithstanding, unless otherwise ordered by the Chief Judge, this appointment shall remain in effect for a period of two (2) years commencing February 1, 2018, and terminating at the close of the day on January 31, 2020.

6. Pursuant to K.S.A. 20-380, the District Court Trustee shall provide the Chief Judge with a yearly budget at the beginning of each year and a statement of fees and expenses at the end of each year. In addition, the Trustee shall provide such other information as may be requested by the Chief Judge or other Judge of the District Court of Shawnee County, Kansas. For the purpose of this Order, the term "judge" shall include an Administrative Hearing Officer appointed by the Court.

7. As his fee, the District Court Trustee shall be paid 4.00% of current support

collected on non IV-D cases, up to a maximum of \$40.00 per month per case. In addition, the Trustee shall be paid 4.00% of all arrearages collected on non IV-D cases, with no monthly maximum.

8. The District Court Trustee shall maintain legal malpractice insurance and liability insurance.

9. The District Court Trustee shall indemnify and hold the District Court and Shawnee County harmless for any claims and/or losses related to his service as District Court Trustee.

10. The District Court Trustee shall have all of the duties and all of the powers set forth in K.S.A. 20-377 *et seq.*, as amended.
