ORDER FOR HOUSE ARREST

NOW ON THIS _____ day of _____, 20____, the Court, after being duly informed of the facts in the above-entitled matter, orders the following:

The Defendant will be placed under house arrest commencing on _____, 20____, for a period of _____ days after serving _____ days/hours in the Shawnee County Department of Corrections. Within the period of house arrest, the Defendant shall serve a minimum of _____(120)(2160) hours of confinement within the boundaries of the Defendant's residence.

It is the order of the Court that the Defendant shall comply with the following terms of house arrest:

1. The defendant will be released directly to the house arrest provider.
2. The defendant will obtain permission from the house arrest provider before changing residences or mailing addresses. The defendant must remain within the property boundaries of his or her residence as directed by the house arrest provider and may not

deviate from those hours without specific, prior permission from the provider. Failure to do so can result in a violation of this order.

3. The defendant must allow the house arrest provider entry into his or her property boundaries for compliance checks.

4. The defendant must either live in an area that gets cellular service or have a landline to comply with this order. For contact in non-compliance situations, the defendant must have a form of communication available at all times, either landline phone or cell phone. The defendant must maintain electrical services at the place of residence as directed. The defendant must notify the house arrest provider with any phone number changes. The defendant shall maintain a working telephone that does not contain the capacity to forward calls and shall not have an answering machine on the telephone when the defendant is supposed to be at home.

5. The defendant shall be confined to his home at all times except for:

- a) Working or traveling directly to and from approved employment or educational programs;
- b) Going to and from prior approved places of business to make application for employment;
- c) Undergoing scheduled medical, psychiatric, or mental health treatment or approved counseling and aftercare programs, including AA or NA;
- d) Attorney visits or court hearings;
- e) Religious services; and
- f) Reacting to medical emergencies.

6. The defendant will not leave Shawnee County without permission from the house arrest provider.

7. The Defendant shall provide _____ (supervising house arrest agency) with the following information:

- a) Hours and location of employment;
- b) Hours and location of additional activities set out in paragraph 4;
- c) Class schedule, if enrolled in approved educational program;
- d) Schedule of all medical and counseling appointments;
- e) Court dates;
- f) Religious services; and
- g) Schedule of all approved aftercare programs (AA/NA).

8. The defendant shall not commit another offense during the period of house arrest. The defendant must notify the supervising house arrest agency of any law enforcement contact within 24 hours.

9. The defendant must not possess, transport, or use any firearms, explosives, or dangerous or deadly weapons.

10. The defendant is required to have a house arrest monitoring system and remote alcohol monitoring device from an approved house arrest provider.

11. The defendant shall not consume or possess any cereal malt or alcoholic beverage or illegal drugs and shall not associate with persons or places where alcohol, cereal malt beverages, or illegal drugs are sold, distributed, or consumed.

12. The defendant shall submit to random drug and alcohol testing at any time when requested to do so by _____ supervising house arrest agency or any law enforcement official. Failure to do so will be considered a violation of the house arrest agreement.

13. Refusal to answer phone, send required picture, take a breath test, or submit to random drug and alcohol testing can be considered a violation and will result in immediate suspension of house arrest.

14. The Defendant shall follow any special condition specified by the Court.

15. The Defendant agrees to pay the supervision fees for participating in the electronic monitoring program. The payment of this fee is a condition of participating in this program.

16. The supervising house arrest agency shall submit an affidavit to the Shawnee County District Attorney's Office within 72 hours outlining any terms or conditions that the defendant violated in regard to the house arrest order.

17. The Court may, at any time, revoke the Defendant's house arrest privilege for cause, modify the conditions of house arrest, and reduce or extend the period of house arrest as provided by law. The Court may issue a warrant for the Defendant's arrest or the Court Service Officer may arrest without warrant for violation of any of the house arrest conditions.
